**Milan, February 14, 2022** – Webuild S.p.A. informs that it has purchased, in the week of February 7-11, 2022 included, no. 419,469 ordinary treasury shares (LEI: 549300UKR289DF4UXQ47), at an average price of Euro 1.7896 per share, for a total value of Euro 741,442.32 as part of the purchase authorization approved by the Shareholders' Meeting on April 30, 2021.

The purchases were made through the intermediary Intermonete S.p.A..
