Milan, May 23, 2022 – Webuild S.p.A. informs that it has purchased, in the week of May 16-20, 2022 included, no. 286,766 ordinary treasury shares (LEI: 549300UKR289DF4UXQ47), at an average price of Euro 1.6576 per share, for a total value of Euro 474,857.21 as part of the purchase authorization approved by the Shareholders' Meeting on April 28, 2022.

The purchases were made through the intermediary Intermonete S.p.A.
