WEBUILD: UPGRADE OF GROUP'S CDP'S RATING IN CLIMATE CHANGE PROGRAMME TO "A-", PLACING WEBUILD IN THE LEADERSHIP SECTION

NEW RECOGNITION OF INTERNATIONAL STANDING FOR THE GROUP'S COMMITMENT TO LAW ENFORCEMENT ACTIONS ON A GLOBAL SCALE

- *CDP (formerly Carbon Disclosure Project) recognized the Group's leadership in mitigating climate change risks*
- *Webuild received an "A-" rating, placing itself in the "Leadership" area*
- *Rating above European regional average and above average in the construction sector*

Milan, December 23, 2022 – Webuild Group's rating in CDP's Climate Change 2022 Programme (formerly the Carbon Disclosure Project) grows to "A-," in "Leadership" section. Webuild's ranking emerges compared to that of some 15,000 companies assessed on a global scale by CDP and is further recognition of the Group's leadership in mitigating climate change risks. Webuild ranks among the 23 percent of assessed companies that received Leadership level in the relevant industry. The "A-" rating is also higher than the regional average (equal to "B") and the average for the construction sector (equal to "C").

CDP (formerly Carbon Disclosure Project) is an international non-profit organization that annually assesses companies involved in the survey, on behalf of over 680 investors who represent assets for over 130,000 billion dollars. The formulated assessment considers corporate commitment in identifying and managing risks connected to climate change, and in meeting the challenges brought about by this very change, while also setting ambitious and challenging goals.

Webuild, for a few years already, accelerated its commitment to fighting climate change. Last year it launched the ESG Plan 2021-2023, focusing on three strategic themes (Green, Safety & Inclusion, Innovation) that identifies clear medium- and long-term goals including reducing greenhouse gas emissions, including by accelerating investment in innovative projects with high potential in terms of sustainability. In the area of Climate Change, 2022 Webuild's targets for 2030 emission reduction were also validated by Science Based Targets initiative (SBTi).

Webuild's commitment in the sector has already received international accolades, winning important, stable or growing positionings in the sustainability ratings issued by VigeoEiris (Advanced rating), ISS-Oekom (Prime rating) and EcoVadis. In 2021, Webuild also won an "A" rating from MSCI (Morgan Stanley Capital International) ESG Research, especially thanks to the consolidation of the Company's governance and its attention to its Board's independence and diversity.

Webuild, the new Group born in 2020 from Salini Impregilo, is a leading global player in the construction of large, complex projects for sustainable mobility (rail, metro, bridges, roads, ports), hydropower (dams, power plants), water (treatment and desalination plants, wastewater management, irrigation dams) and green buildings (civil and industrial buildings, airports, stadiums, hospitals). It supports clients in achieving the Sustainable Development Goals (SDGs) established by the United Nations. The Group ranks first in the world for the construction of infrastructure in the water sector. Since 2018, it is also among the top 10 companies by revenue generated from environmental services. Webuild is the expression of 116 years of engineering experience applied in 50 countries with 80,000 direct and indirect employees from more than 100 nationalities. Iconic projects, completed or under construction, include the M4 metro line in Milan, a section of Line 16 of the Grand Paris Express, Cityringen in Copenhagen, the viaduct and bridge for



Sydney Metro Northwest in Australia, Red Line North Underground in Doha, Line 3 of Riyadh Metro and high-speed railways in Italy. Others include the Genova San Giorgio Bridge in Italy, the Long Beach International Gateway Bridge in Long Beach, California, the expansion of the Panama Canal, the Snowy 2.0 hydroelectric scheme in Australia, the Rogun hydroelectric dam in Tajikistan, the Anacostia River and Northeast Boundary hydraulic tunnels in Washington, D.C., and the Al Bayt 2022 World Cup stadium in Qatar. At June 30, 2022, the Group had a total order backlog amounting to more than €47 billion, with 90% of the construction backlog relating to projects linked to SDGs. Webuild, subject to direction and coordination by Salini Costruttori S.p.A., is headquartered in Italy and is listed on the Milan stock exchange (Borsa Italiana: WBD; Reuters: WBD.MI; Bloomberg: WBD:IM).
