**Milan, October 2, 2023** – Webuild informs that it has purchased, in the week of September 25-29, 2023 included, no. **40,000** ordinary treasury shares (equal to **0.004** % of the ordinary share capital and **0.81%** of the total volume of the exchanged shares) for an overall countervalue of € 67,065.00.

In light of the above, the total amount of ordinary treasury shares held by the company as of September 29, 2023, amounts to **21,235,392** ordinary treasury shares, the equivalent of **2.094%** of the ordinary share capital.

The purchases were made through the intermediary Intermonete S.p.A.
