**Milan, November 10, 2023** – Webuild informs that it has purchased, in the week of November 6-10, 2023 included, no. **120,000** ordinary treasury shares (equal to **0.012 %** of the ordinary share capital and **1.75%** of the total volume of the exchanged shares) for an overall countervalue of **€ 207,049.56**.

In light of the above, the total amount of ordinary treasury shares held by the company as of November 10, 2023, amounts to **21,432,392** ordinary treasury shares, the equivalent of **2.113%** of the ordinary share capital.
