CSC (WEBUILD GROUP): NEW CONTRACT WORTH IN TOTAL €302 MILLION TO BUILD THE NEW INDUSTRIAL RAILWAY PLANT (*NUOVO STABILIMENTO INDUSTRIALE FERROVIARIO*) IN TICINO, SWITZERLAND.

FROM CSC TO LANE, CLOUGH AND FISIA: SUBSIDIARIES CONTRIBUTE TO THE GROUP'S GROWTH IN LOW-RISK STRATEGIC MARKETS

Milan, May 23, 2024 – A new project in Switzerland was won by the Webuild Group. *CSC Costruzioni,* a Group subsidiary, has won a contract worth a total of over €302 million for the *Nuovo Stabilimento Industriale Ferroviario* (NSIF) project in Ticino, Switzerland, with a 67% share that amounts to €202 million.

The work was commissioned by FFS (*Ferrovie Federali Svizzere*) to the *Consorzio Officine Ticinesi OFT* consortium led by *CSC Costruzioni*, which will implement the preparatory works like installing the construction site and carrying out the excavation works, and then constructing the main building, the nearby technical buildings, and all works for the external areas.

Works are expected to begin at the start of July 2024 and will end by 2027, when the *Nuovo Stabilimento Industriale Ferroviario* will be opened for use.

CSC is one of Webuild's subsidiaries that contributes to driving the Group's growth in low-risk markets that are also competitive and with growing trends to investing in infrastructures: from Lane to the United States, to *Clough* in Australia; or *Fisia Italimpianti* and *Cossi Costruzioni*, respectively specialised in the water, tunnelling, road maintenance sectors, in Italy.

CSC Costruzioni has been present in Switzerland for over 60 years, designing and constructing sustainable works, with over 20 ongoing projects. The company is currently engaged in constructing highly technological and innovative projects like the extension of the Data Centre for the client, Safe Host, at Gland (the Vaud Canton), in Switzerland. It is also working to restructure the historical buildings of the United Nations Offices in Geneva. CSC has also recently completed Parc du Simplon, a green building project for urban redevelopment, which has led to a new neighbourhood, only 5 kilometres away from downtown Lausanne, with residential and commercial buildings.

Webuild is a global leader in the design and construction of large, complex projects in the sectors of sustainable mobility, hydropower, water management and production, and green buildings. For many years, the recognized leader in the water sector, also ranking among the Top 10 international players in Australia, Europe and the US, the Group has consolidated experience in 50 countries. In almost 120 years of applied engineering on more than 3,200 projects, the Webuild Group has built 14,140 kilometres of rail and metro lines, 82,533 kilometres of roads and highways, 1,020 kilometres of bridges and viaducts, 3,408 kilometres of tunnels, and 313 dams and hydropower plants. Projects include the Bridge over the Danube River in Braila in Romania, and the Genoa Long Beach International Gateway in California; the expansion of the Panama Canal and the Third Bosphorus Bridge in Turkey; the Kingdom Centre skyscraper in Riyadh in Saudi Arabia, and the metros in Copenhagen, Paris, Rome and Milan, Doha and Ryadh. Projects under construction include the New Genoa Breakwater, the Brenner Base Tunnel, Line 4 of Milan's metro, and Line C of Rome's metro, the Genoa-Milan high-capacity railway line, the Snowy 2.0 hydroelectric project in Australia, and the Trojena project for NEOM in Saudi Arabia. As of December 31, 2023, the Webuild Group with 87,000 people, achieved €10 billion in total revenues, and a total backlog of €64 billion, with over

90% of its construction backlog related to projects linked to the advancement of the United Nations Sustainable Development Goals (SDGs). Webuild, subject to the direction and coordination of Salini Costruttori S.p.A., is headquartered in Italy and is listed on the Milan stock exchange (WBD; WBD.MI; WBD:IM). Since 2021, it is member of the MIB ESG, the index of Italian companies with the best ESG practices.
