Milan, June 24, 2024 – Webuild informs that it has purchased, in the period June 17-21, 2024 included, no. **118,000** ordinary treasury shares (equal to **0.012%** of the ordinary share capital and **0.79%** of the total volume of the exchanged shares in the aforementioned period) for an overall countervalue of **€234.403,90**.

In light of the above, the total amount of ordinary treasury shares held by the company as of June 21, 2024, amounts to **25,292,211** ordinary treasury shares, the equivalent of **2.485%** of the ordinary share capital.
