**Milan, August 12, 2024** – Webuild informs that it has purchased, in the period August 5-9, 2024 included, no. **170,000** ordinary treasury shares (equal to **0.017%** of the ordinary share capital and **2.37%** of the total volume of the exchanged shares in the aforementioned period) for an overall countervalue of **€377,847.76**.

In light of the above, the total amount of ordinary treasury shares held by the company as of August 9, 2024, amounts to **25,727,437** ordinary treasury shares, the equivalent of **2.528%** of the ordinary share capital.
